Maharshi Ved Vyas Government PG College located in rural area is affiliated to Pt. Ravishankar Shukla University, Raipur. It strictly follows all the rules and regulations according to the academic calendar given by the department of higher education, Govt, of Chhattisgarh and implements the university curriculum keeping in mind the students of the territory who mostly belong to SC/ST/OBC community. The college encourages students to participate in various programs to inculcate in them environmental concerns and the attitude to learn the local history. The institute also focuses on language and computation skills, and personal improvement of the students. It has been observed that the college provides higher education to the socially and economically weaker rural students. The college has set its own vision, mission and objectives to achieve through the curricular, co- curricular and extracurricular activities. Various skill development programmes such as slogan writing, debate, short plays, street plays and such allied activities are organised within and outside the college. Student feedback on curriculum, faculties to improve the quality of education is taken annually. The institution has incorporated different cross cutting issues relevant to gender, environment and sustainability, human values and professional ethics in its functioning and curriculum delivery as a part of its binding of social commitment with different sections in the society. In addition, the college started Book Bank under RUSA Equity Initiative Fund for facilitating books to SC/ST/Minorities Girls students as well, for entire semester without any cost.

Apart from the final exam conducted by the university, the college also conducts internal exams like unit tests, and pre-university exam as per Academic Calendar. The results of these exams are displayed and discussed by the concerned teachers with the students. The administration takes necessary action against those students who are irregular in attending lecture sessions as well as lab sessions. The attendance register and teaching dairy of the teachers are regularly examined by the principal.

The college offers 12 UG and 8 PG programmes. Student enrollment, recruitment of teachers, and reservation policy is as per the rules and regulations of the Pt. Ravishankar Shukla University, Raipur and department of higher education Govt, of Chhattisgarh. Study tours, industrial visits, wall papers, seminars, projects, workshops etc. justify that teaching-learning process is student centric and caters to diverse needs of the learners. One projector available in the college is installed in one of the classrooms for the use of the entire faculty of the college. The mechanism of evaluation is robust and transparent. The redressal of grievances with respect to evaluation is efficient and time-bound. The conduct of continuous internal evaluation is done adhering to the academic calendar. Various curricular, co- curricular and extra-curricular activities help to attain the POs, PSOs and COs; to inculcate awareness on good citizenship, communication and professional skills, cleanliness, scientific attitude, nationalism etc. among the students.

IQAC plays a vital role to monitor continuous improvement of teaching learning process which facilitates various academic activities by teachers and students of the college. Orientation program is organized at the beginning of the first semester of the academic programs. In addition to traditional lecture method, diverse student centric methods are applied in classroom teaching viz. group discussion method, demonstration method, problem-based learning, Brainstorming sessions etc. Student seminars and workshops are also arranged. The college measures the performance of the students by continuous internal evaluation (CIE) process. The college adopts the CIE process prescribed by the university from time to time. Verified internal evaluation mark-sheets are displayed on college notice board. CCTV surveillance is installed on whole college building to prevent use of unfair means by students in examination.

The college puts efforts to improve the quality of the teaching-learning process. Most of the students belong to the rural community with poor financial background. Almost 70% of the institutional enrolment belongs to the girl students. Students of all categories like ST, SC, OBC etc. in majority come to take admission in this institute. Teachers are encouraged to participate in Orientation Programmes, Refresher Courses, Induction Programmes, Seminars, Workships, and conferences for their professional development. Many Guest faculties have been engaged to maintain the student teacher ratio. The college publishes its annual magazine 'Prayas' regularly.

At present 6 out of 11 permanent teachers have completed Ph.D. and many others are pursuing PhD. Some of the teachers published research papers and books.

Although the college is offering programs at graduation and postgraduation level, it has been striving hard to inculcate critical thinking in students by organizing special programs, poster competitions and various student workshops and seminars by inviting experts of various fields. College Teachers participate in various outdoor conference, seminars and workshops as participants as well as resource persons.

Extension activities: The college is also engaged in various extension activities for community and environmental development. The NSS unit in the college came into existence in 2009 and since then it has been arranging a number of outreach programs and extension activities like Swachch Bharat, environment awareness and other awareness programs. These activities covers blood donation camp, Student helped for Kerela Flood, tree plantation, water and other services in religious and social functions, awareness programs towards nutrition, yoga & meditation.

The career guidance cell of the college give guidance to the students for job oriented competitive exams. The faculty members from science stream provide guidance to student from local community who are appearing in 11th and 12th board exam. The teachers spare time for the students appearing in exams like PET, PAT, PMT, NEET, JEE, NET etc.

The college has a large academic campus having 10 acres of land of which the built-up area is 3389 sq.mt for college building. There are 20 classrooms in the college, out of which one is with LCD projector. Besides, 5 laboratories, One seminar hall, girls and boys' common rooms and staff rooms are there. The napkin vending machine facility is available in the girls' common room. The college arranges sports and games facilities for the students by arranging Volley Ball Court, Shuttle/Ball Badminton Court, Kho Kho Court and other indoor game facilities like Chess, Caroms etc. For the games like football and cricket, the college utilizes the facility of the Panchayat available neat the college. The college has a canteen which is run by a Women Self Help Group of the locality. Further, there are enough separate washrooms for boys and girls. The college should take steps to develop more smart rooms with digital screens. The available infrastructure is not sufficient to meet the increasing number of students enrolled.

The college library functions in a big hall has 15634 books and 534 titles. Barcode facility and smart identity card generation machine are also made available there. The college has biometric attendance for staff. CCTV surveillance system is in place for maintaining discipline and ensuring safety, security and peace on the campus. Efforts are taken to maintain the campus green. The Herbal Garden maintained in the college is used by the students of Botany Department for academic purposes. The open air auditorium of the college is utilized by the cultural forum of college for staging various performances by the students. There are total 30 number of computers in the college which are used for the academic purpose.

Meritorious students are nominated as the office bearers of the students' union by the principal. The students approach the college authorities through the class representatives and the college as and when required.

The college has several committees to work on specific works like cultural events, internal complaint committee, women development cell, anti-ragging committee etc. WDC conducts several activities like self-defense training, gender equity program etc. for the benefit of girl's students.

The college supports to conduct fresher's party when new admissions take place. They observation of various days like Independence Day, The Republic Day, The Teacher's Day gives opportunities for the students to develop their leadership skills. The celebration of the birth anniversaries of Mahatma Gandhi, Sardar Patel, Swami Vivekananda kindles the patriotic spirit of the students and develops self-discipline and helps them follow ethics in their personal and professional life. The institution has a committee which supervises and redresses various grievances of the students including sexual harassment and ragging cases.

The Institute endeavours for capability enhancement and development such as personal guidance to interested students through teachers for competitive examinations and Career counseling, soft skill development, Yoga and meditation, Personal Counseling, etc. Further, the institution has a transparent mechanism for timely redressal of student grievances including sexual harassment and ragging cases. Though not registered, the college has an Alumni association for conducting various activities in the college for connecting the old students with the college. College is near to stadium ground and sports complex of district administration which is utilised by college as per requisition through prior permission.

After getting recognition from the UGC under section 2 (f) & 12 (B), the college formed IQAC and started functioning on 03.07.2018 to enrich the quality of education. Earlier it was monitored by Academic committee formed by the teacher council of the college. The college also has an effective system of informing student about various schemes of scholarship and other information necessary for them.

The college governing body is keen to plan and execute the activities in tune with the vision, mission and core values of the institution. The college administration ensures the transparency by having active participation of stakeholders of the institution. The head of the institution delegates its administrative, academic and general responsibilities to all the other stakeholders. Meetings of IQAC, Staff Council, Janbhagidari Samiti and other committees are held frequently. The principal is the administrative head of the college who is responsible for implementing Government Policies regarding academics. He has to look after the financial management of the college. The institution practices decentralization and participative management in the sense that all the Academic and non-academic activities are being performed by the faculty, Students' representatives and internal cells/committees. The College follows rules and regulations of teachers' recruitment as per UGC, and conduct rule, other service matters as per CCS. The college adopted democratic practices in the Governance and management of the college by including teaching and nonteaching staff in various decision-making purposes through constituted committees. The fund allotted under the budget is spent by the college on various academic, administrative and capital expenditures during the year. College implemented e-governance in various area of operation like planning and development, administration, finance, account, student admission and examinations. Recently a placement Cell has been opened in the college to facilitate job opportunities for the outgoing students.


Graphical Representation based on Quantitative & Qualitative Metrics














Fig: High Performance Key Indicators (3.01-4.0) for the institution









Graphical representation of Strengths and Weakness of the institution based on Q_nM & Q_lM (Criteria I,II and III)




Fig: Graphical representation of Strengths(4) and Weakness(0) of the institution based on QnM & QlM (Criteria I,II and III)




Fig: Graphical representation of Strengths and Weakness of the institution based on QnM & Q1M (Criteria IV,V,VI and VII)
